Exhibitor agrees to setup exhibit on Tuesday, March 20, 2018 between 10am and 4pm. Exhibitor agrees that no portion of the display will be removed prior to 8 PM on the last day of the event. However, Exhibitor agrees to have everything removed from the Fairgrounds by NOON the day after the event is over.

That the Exhibitor agrees to indemnify and save harmless Pinal County, Central Arizona Fair Association, Fair Executives, their officers, agents and employees from any and all claims, causes of actions and suits occurring or resulting from any damage, injury or loss to any person or persons, including but not limited to persons to whom the Exhibitor may be liable under Workmen's Compensation law and the Exhibitor himself and from any loss of property, goods, wares or merchandise, caused by arising out of or in any connected with the exercises by the Exhibitor of the privileges herein granted. The Exhibitor further agrees to obtain his own insurance against risk of all kinds and description and to indemnify Pinal County, Central Arizona Fair Association, Fair Executives, their officers, agents and employees from and against all claims and demands, costs, charges and expenses which it may incur, suffer or be put to in connection with the use of said premises by said Exhibitor.
